## 3. MINUTES

Following review of the Minutes, it was noted **M/S/C** to approve the May 29, 2913 Minutes as presented.

## A. Kaufmann and Goble

## B. Appeal #06272013-A

The Trustees reviewed Appeal #06272013-A relating to a member's request to award him his Part B Disability benefits per the Plan rules. The Trustees reviewed a letter from Dr. Swann from WorkCare, Inc. who noted that the member does not qualify as Totally and Permanently Disabled from performing his work as an electrician. The member was sent a denial letter. The appeal was sent out for a second review. The Trustees reviewed a letter from American Health Holdings for a second review of the disability appeal. The Dr. found the member to be Totally and Permanently Disabled. Following discussion, it was **M/S/C** to grant Appeal #06272013-A as presented.

## C. Notices to Employers and Employees About the New Plan

The Trustees reviewed two notices: One to All Participants, Beneficiaries, Alternate Payees and Employers and the Union advising that the Trustees voted to discontinue the money purchase contributions to the Plan and replace them with a mandatory employer contribution coupled with a voluntary employee elective deferral 401(k) feature effective July 1, 2013.

The Trustees also reviewed a notice to Employers advising them of the change that will be effective July 1, 2013.

## D. <u>Discussion About Annual Meetings</u>

Due to some confusion about the date for the 2013 meeting at Quail Lodge, the 2014 Annual Meeting will be held from September 24-26. Quail Lodge is holding the meeting space in 2014, as well as the deposit that was paid to Quail Lodge during 2013. Rates in 2014 will remain as proposed in the 2013 contract.

#### A. <u>Amendment for Profit Sharing Plan</u>

Discussion took place about implementing this Amendment as respects employer reporting under Union Manager. Mr. Kaufmann said other groups have had meetings with employer payroll managers to explain new programs in the past.
