3. MINUTES

Following review, it was M/S/C to approve the January 26, 2012 Minutes as presented.

4. CORRESPONDENCE

5. <u>DISBURSEMENTS AND RECIPROCITY REPORT</u>

The Trustees reviewed disbursements for checks 3412 to 3420. The Trustees also reviewed the Outgoing Reciprocity Report paid through ERTS for December 2011. It was **M/S/C** to approve the disbursement report and the Outgoing Reciprocity Report for the month of December 2011.

6. FINANCIAL STATEMENT

The financial statement for December 2011 was not yet available. It will be presented for review at the March 2012 trust meeting since it is for calendar year end 2011.

7. REPORT BY INVESTMENT CONSULTANT – ALAN BILLER & ASSOCIATES

Mr. Hennessy updated the Trustees on the addition of MainStay to the three Part B model portfolios and showed the Trustees the new Schedule 2 for the Plan B IPS. Ms. Vukson asked for clarity regarding next steps. She was directed by the Trustees to add MainStay as an additional Part B choice at the end of March, with all Growth Fund of America monies to be mapped over to MainStay at the end of June.

Mr. Hennessy also noted that Wilmington Trust had not yet taken over custody of the Ferguson Wellman Large Cap Core accounts from BNY Mellon, but that Ms. Sargent and Mr. Kaufmann were making sure that the change of custody would occur.

8. REPORT BY ADMINISTRATOR

A. Mandatory Distributions

The Trustees reviewed **two**mandatory distributions for the month of February 2012. It was **M/S/C** to approve the distribution as presented.

B. Appeal 02232012-A

The Trustees reviewed Appeal 02232012-A in which a member previously requested to withdraw his Part B funds and was denied because he did not meet eligibility requirements. The Member reported hours from 1999 to 2002 and his Part A has terminated due to a permanent break in service. Member is now requesting his Part B fund to his home Local 177 in Jacksonville, Florida.

Ms. Lopez noted that she has been unable to reach the Local 177 Administrative Office to inquire if they will accept an Inter Plan Transfer from Local 332.

Following discussion, it was **M/S/C** to deny Member request for a lump sum withdrawal. Further, it was **M/S/C** to approve an Inter-Plan Transfer to Local 177 in Jacksonville, Florida contingent upon Local 177's affirmative response.

C. Educational Meeting

It was reported that the next educational meeting will be held at the Union Hall on Thursday, March 8, 2012 from 6:00 p.m. to 7:30 p.m.

D. <u>Annual Meeting Proposals – 2012</u>

As follow-up to a request at the last meeting, the Administrator provided the Trustees with a summary of proposals from four hotels for this year's Annual Meeting. Following discussion, the Trustees directed the Administrator to obtain proposals from hotels in San Francisco that are union hotels. It was agreed that the Annual Meeting 2012 be held on October 16-19.

E. <u>Administrative Services Agreement</u>

The Administrator provided a revised copy of its Administrative Services Agreement, which was reviewed and approved by Legal Counsel prior to this meeting. Following discussion, it was **M/S/C** to approve the Administrative Services Agreement effective March 1, 2012 and the Chairman and Co-Chairman executed the Agreement.

9. REPORT BY KRAW & KRAW, ATTORNEYS

A. <u>Final Service Provider Fee Disclosure Regulations</u>

The Trustees reviewed a memo from Kraw &Kraw dated February 22, 2012 relating to the Department of Labor (DOL) issuing the final service provider fee disclosure regulations, effective July 1, 2012. Ms. McDonough provided an overview of the disclosure requirements and highlighted some of the key elements of the regulation that will impact multiemployer pension and defined contribution plans.

Ms. McDonough noted that she is working with the Administratorand Consultant to develop a questionnaire that will be distributed to covered service providers to ensure their compliance with these new requirements.
